A MOTION WAS MADE BY RAY MATTHEW AND SECONDED BY JIMMY MARLER TO ACCEPT THE TREASURER'S REPORT. THE MOTION PASSED BY ROLL CALL VOTE 9 YEAS.

OLD BUSINESS
