## ORDINANCE NO. 2024-12

BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF FULTON, STATE OF ARKANSAS,  
AN ORDINANCE TO BE ENACTED:

AN ORDINANCE APPROPRIATING PUBLIC FUNDS FOR THE EXPENSES OF THE COUNTY FOR THE  
YEAR 2024

WHEREAS ARK. STAT. ANN. 17-001 (b) REQUIRES THE QUORUM COURT OF FULTON COUNTY,  
ARKANSAS, TO APPROPRIATE PUBLIC FUNDS FOR THE EXPENSES OF THE COUNTY EACH YEAR  
BY ORDINANCE.

THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FULTON COUNTY, ARKANSAS;

ARTICLE I. THAT THE PARTICULAR FUNDS, AS HEREIN AFTER SET OUT ARE HEREBY  
APPROPRIATED TO BE APPLIED TO THE RESPECTIVE PURPOSES SET FORTH HEREIN:

ARTICLE II. THAT THERE IS HEREBY APPROPRIATED:

\$100,000 COUNTY ROAD PARTS AND REPAIRS \$60,000/GRAVEL, DIRT, & SAND \$40,000

\$175,000 JAIL SALES & USE TAX BOND FUND 2011 ADDITIONAL BOND PAYMENT


\$8,312.50 COUNTY ROAD SALARIES \$6,720/SS MATCH \$514.08/RET MATCH \$1,029.50/UNEMPLOYMENT \$48.92

\$8,977.73 LAW ENFORCEMENT SALES TAX SALARIES \$7,837.64/SS MATCH \$599.58/RET MATCH \$540.51

TRANSFER LAW ENFORCEMENT SALES TAX \$12,500 FROM BLDG MATERIALS & SUPPLIES TO ENGINEERING & ARCHITECTURAL
