THE FULTON COUNTY QUORUM COURT MET IN REGULAR SESSION UPSTAIRS IN THE FULTON COUNTY COURTHOUSE. THE MEETING OPENED WITH PLEDGE AND PRAYER.

ROLL CALL BY CLERK BISHOP WITH 8 JUSTICES PRESENT. JUSTICE ELLIOTT WAS ABSENT.

A MOTION WAS MADE BY DENNIS KINDER AND SECONDED BY JIMMY MARLER TO ACCEPT THE MINUTES. THE MOTION PASSED BY ROLL CALL VOTE 8 YEAS.

A MOTION WAS MADE BY CARRIE ANDREWS AND SECONDED BY DENNIS KINDER TO ACCEPT THE CLERK'S REPORT. THE MOTION PASSED BY ROLL CALL VOTE 8 YEAS.

A MOTION WAS MADE BY GARY PHILLIPS AND SECONDED BY CRIS NEWBERRY TO ACCEPT THE TREASURER'S REPORT. THE MOTION PASSED BY ROLL CALL 8 YEAS.

ROAD FOREMAN JOSH SMITHEE GAVE A ROAD REPORT.

OLD BUSINESS

JUDGE CROW GAVE AN UPDATE ON THE COURTHOUSE RENOVATION.

A MOTION WAS MADE BY ALBERT ROORK AND SECONDED BY JIMMY MARLER TO PLACE AN ORDINANCE DIRECTING THE FULTON COUNTY CLERK AND PERSONNEL POLICY COMMITTEE TO AMEND CURRENT POLICY. ORDINANCE 2024-11 WAS READ BY THE CLERK AND PASSED WITH ROLL CALL VOTE 8 YEAS. THE ORDINANCE WILL BE READ THE NEXT TWO MONTHS

ASSESSOR LONG GAVE AN UPDATE ON THE GIS PROJECT. THE BID WAS AWARDED TO MAPPING SOLUTIONS FOR \$68,137.60. THIS IS A 60/40 GRANT. THE STATE WILL PAY \$40,882.56 AND THE COUNTY WILL PAY \$27,255.04. THIS WILL APPROXIMATELY BE AN 18 MONTH PROJECT.

NEW BUSINESS

JUDGE CROW ASKED FOR \$100,000 APPROPRIATION FROM THE ROAD DEPARTMENT. A MOTION WAS MADE BY ALBERT ROORK AND SECONDED JIMMY MARLER TO APPROPRIATE \$100,000 COUNTY ROAD PARTS AND REPAIRS \$60,000/GRAVEL, DIRT, AND SAND \$40,000. THE MOTION PASSED BY ROLL CALL 8 YEAS.

JUDGE CROW STATED HE HAD ADDED THE SMITH FORD BRIDGE TO THE LOCAL BRIDGE PROJECT, AND WAS REQUESTING A RESOLUTION. CLERK BISHOP READ RESOLUTION 2024-04 A RESOLUTION EXPRESSING THE WILLINGNESS OF FULTON COUNTY TO UTILIZE FEDERAL – AID MONIES FOR THE PROJECT OF SOUTH FORK SPRING RIVER BRIDGE REPLACEMENT ON FERNWOOD ROAD. A MOTION WAS MADE BY ALBERT ROORK AND SECONDED BY GARY PHILLIPS TO ADOPT THE RESOLUTION. THE MOTION PASSED BY ROLL CALL VOTE 8 YEAS. (RESOLUTION 2024-04)

JUDGE REQUESTED AN APPROPRIATION FOR AN ADDITIONAL JAIL BOND PAYMENT ON PRINCIPAL. A MOTION WAS MADE BY RAY MATTHEW AND SECONDED BY CRIS NEWBERRY TO APPROPRIATE \$175,000 JAIL SALES & USE TAX BOND FUND 2011 ADDITIONAL BOND PAYMENT. THE MOTION PASSED BY ROLL CALL 8 YEAS.

JUDGE CROW REQUESTED THE ROAD DEPARTMENT TO HAVE AN ADDITIONAL PART TIME CDL TRUCK DRIVER FOR 3 DAYS A WEEK OR AS NEEDED. A MOTION WAS MADE BY ALBERT ROORK AND SECONDED BY CRIS NEWBERRY TO APPROPRIATE **\$8,312.50** COUNTY ROAD SALARIES \$6,720/SS MATCH \$514.08/RET MATCH \$1,029.50/UNEMPLOYMENT \$48.92. THE MOTION PASSED BY ROLL CALL VOTE 8 YEAS.

SHERIFF SMITH ADDRESSED THE COURT STATING THERE HAD BEEN SOME CONFUSION ON ERICA'S SALARY, AND SHE HAS GONE OVER BUDGET. HER LAST DAY WILL BE ON THE AUG 28TH, SO HE IS REQUESTING THE DIFFERENCE OF SALARY \$3,528.14/SS MATCH \$269.90/RET MATCH \$540.51 PLUS HER REPLACEMENT AT \$13 AN HOUR FOR 39 HOURS PER PAY PERIOD SALARY \$4,309.50/SS MATCH \$329.68. AFTER DISCUSSION, A MOTION WAS MADE BY ALBERT ROORK AND SECONDED BY DENNIS KINDER TO APPROPRIATE \$8,977.73 LAW ENFORCEMENT SALES TAX SALARIES \$7,837.64/SS MATCH \$599.58/RET MATCH \$540.51. THE MOTION PASSED BY ROLL CALL VOTE 8 YEAS.

SHERIFF SMITH STATED THE ARCHITECT WAS REQUESTING BLUEPRINTS FOR THE JAIL EXPANSION. AFTER DISCUSSION ON THE EXPANSION PROCESS, SHERIFF REQUESTED A LINE-ITEM TRANSFER LAW ENFORCEMENT SALES TAX \$12,500 FROM BLDG MATERIALS & SUPPLIES TO ENGINEERING & ARCHITECTURAL. A MOTION WAS MADE BY JIMMY MARLER AND SECONDED BY ALBERT ROORK FOR THE TRANSFER. THE MOTION PASSED BY ROLL CALL VOTE 8 YEAS.

A MOTION WAS MADE BY CRIS NEWBERRY AND SECONDED BY JIMMY MARLER TO APPROVE THE ABOVE APPROPRIATIONS AND TRANSFERS ON ORDINANCE 2024-12. THE MOTION PASSED BY ROLL CALL VOTE 8 YEAS. (ORDINANCE 2024-12) (TOTAL APPROPRIATION \$292,290.23)
