A MOTION WAS MADE BY JIMMY MARLER AND SECONDED BY CRIS NEWBERRY TO ACCEPT THE MINUTES. THE MOTION PASSED BY ROLL CALL VOTE 8 YEAS.

SHERIFF SMITH ASKED FOR TWO PART TIME POSITIONS TO BECOME ONE FULL TIME. A MOTION WAS MADE BY ALBERT ROORK AND SECONDED BY CRIS NEWBERRY TO APPROPRIATE \$10,414.61 LAW ENFORCEMENT FUND RETIREMENT MATCH \$5,170.58/HEALTH INSURANCE \$5,172.03/LIFE INSURANCE \$72. JUDGE STATED THE LIBRARY WAS REQUESTING AN APPROPRIATION FOR THE MAMMOTH SPRING LIBRARY MONEY THAT WAS APPROPRIATED LAST YEAR BUT WASN'T SPENT. A MOTION WAS MADE BY JIMMY MARLER AND SECONDED BY GARY TANNER TO APPROPRIATE \$8,300 COUNTY LIBRARY GRANTS-IN-AID (MS). THE MOTION PASSED BY ROLL CALL VOTE 8 YEAS.

JUDGE STATED A CLEAN UP OF OLD RECORDS THAT WERE ABLE TO BE DESTROYED HAS BEEN DONE THROUGH A GRANT. A MOTION WAS MADE BY GARY TANNER AND SECONDED BY GARY PHILLIPS TO APPROPRIATE \$1,401.45 COUNTY GENERAL GRANTS-IN-AID OTHER PROFESSIONAL SERVICES (GRANT) SHRED IT.
